APPLICATION TO REQUEST SERVICES OF TEMPLE PRIEST AT EXTERNAL ENGAGEMENT (“Application”)

An individual or entity (“Devotee”) can arrange to engage the services of the chief priest/assistant priest (“Priest”) of the Guruvayurappan Temple of Brampton (“Temple”) at religious engagements taking place outside the Greater Toronto Area (GTA) (“out-of-town engagements”).

Every out-of-town engagement (“Engagement”) is subject to the terms and conditions outlined in SECTION B.

SECTION B: TERMS AND CONDITIONS

A. Approval and Consent

All Engagements are subject to the availability of the Priest for the period of the Engagement, the consent of the Priest and the approval of the Temple Administrator.

The Devotee shall be responsible for all costs and ancillary expenses incurred by the Priest, including but not limited to all costs associated with travel, fuel, accommodation, food and other disbursements incurred during the Engagement.

B. Bookings and Donation

- i) Bookings for the Engagement can only be made through the Temple Administrator.

For and in consideration of the services performed by the Priest, the Devotee shall donate to the **Temple \$401.00 per day for periods of over three days, \$501.00 per day for one day to three days** (computed from the time the Priest leaves the Temple to when he returns to the Temple). This rate is applicable to only Temples and other Religious Centers. For private individuals and groups the rate will remain as CDN \$501 per day. Part of a day will be treated as one day. Donations are to be given to the Temple Administrator by the Devotee before the Engagement in return for a receipt. All donations that are paid by cheque should be drawn in favour of "GURUVAYURAPPAN TEMPLE OF BRAMPTON". The Engagement will only be confirmed upon issue of the receipt by the Temple Administrator.

The Donation made to the Temple does not include any Dakshina.

C. Indemnity

The Devotee shall indemnify the Priest, the Temple and all Temple employees and agents for all liability, costs and expenses arising directly or indirectly out of any act or omission of the Devotee or the Devotee's employees or otherwise arising out of the Priest's performance of services during the Engagement.

The Devotee shall indemnify and hold the Priest, the Temple and all Temple employees and agents harmless from, and must pay the Temple on demand

- o the amount of any loss (including damage) suffered by any property owned by or under the control of the Priest, the Temple and all Temple employees and agents; and
- o any loss or claim suffered or incurred by the Priest, the Temple and all Temple employees and agents in connection with:
 - o any injury or loss of life of any kind; or
 - o any loss (including damage) to any property; and
 - o the provision of the religious services (including in each case, consequential loss) arising directly or indirectly out of or in connection with any act or omission (including negligence) of the Priest, the Temple and all Temple employees and agents in providing or failing to provide the services during the Engagement.

D. Relationship

The Priest is, and throughout this Engagement shall be, an employee of the Temple and not an employee, partner or agent of the Devotee. Reference to the Priest in any materials that reference the Engagement should include the phrase "The Priest and Thantry of Guruvayurappan Temple of Brampton, Canada".

E. Governing Law

This Application shall be governed by and construed in accordance with the Laws of the Province of Ontario and the applicable federal laws of Canada. The Devotee and the Temple irrevocably and unconditionally submit to the exclusive jurisdiction of the Provincial or Federal Courts located in the province of Ontario for the purpose of any action or proceeding brought by either of them in connection with this Application.

This Application may be amended in whole or in part only by the written consent of the Temple, and the Devotee. Neither party may assign its rights under this Engagement without the prior written consent of the other party hereto. Any attempt to do so shall be a breach of this Application and shall be void.

F. Representations and Warranties

The Devotee represents, warrants and undertakes that:-

- (a) the Devotee is fully entitled to enter into this Application and to perform all the Devotee's obligations hereunder;

(b) acknowledging that the Temple and the Priest have important reputations to protect, the Devotee shall not violate the rights of the Temple or the Priest or contravene the laws of Canada **AND where appropriate** the United States of America.

G. Visa

The Engagements is subject to the issue of all visas the Priest would require for travel to the Engagement and for discharging the Services (“Visas”).

The Devotee shall be solely responsible for filing all applications related to the procurement of all required Visas and shall pay all associated fees, costs and other incidental expenses associated with the application for and procurement of all required Visas.

The Devotee shall be solely responsible for maintaining the validity of all required Visas for the duration of the Engagement.

H. Living Arrangements

The Devotee shall provide the Priest with living arrangements commensurate with the standards and conditions of living arrangements provided by the Temple for the duration of the Engagement.
